Located in the heart of Schuylerville, Fort Hardy Park is the center for active and passive recreation. Steeped in history, the Park was the site that the British laid down of arms at their surrender to the Colonials, ultimately resulting in the first major victory for the Americans. Today the Park hosts baseball and softball fields, youth activities and recreation, waterfront access and recreation, and passive open space. A Master Plan for the Park is under development to examine the existing Park features and reimagine the Park's programming to improve the efficiency of space and unlock its full potential.
