The Public Hearing regarding the amendment to Village Code §151-19 with respect to seasonal parking was opened by Mayor Carpenter with the pledge of allegiance.

Only one member of the public was present, Patricia Smola of 5 Schuyler Island Drive. Ms. Smola was in favor of the changes to the on-street parking law. Trustee LeBaron attended several of the community conversation meetings (local business owners meet monthly to discuss issues and events) to trouble shoot with the business owners the hazardous situation that having cars parked on Broad Street both day and night was causing as pertains to the NYS DOT being unable to remove the snow from the streets as well as our village DPW not being able to remove snow from the road verge (the area between the street and the sidewalk.) An additional concern that was raised by the village board at a previous meeting is that if we only limit parking on Broad Street during the hours of 12:00 am midnight to 6:00 am, this will most likely result in people parking on Ferry Street. This would cause a hazardous situation on the section of Ferry Street that is East of Broad. Different solutions were discussed at these meetings and the following solution was agreed upon;

- (1) For **Broad Street**, parking is permitted each day from 6:00 a.m. to 11:59 p.m. the same day. Parking is **prohibited** at all other times, which includes each day between the hours 12:00 a.m. to 6:00 a.m.
- (2) For **Ferry Street** (State Route 29) **located east of Broad Street**, parking is permitted each day from 6:00 a.m. to 11:59 p.m. the same day. Parking is **prohibited** at all other times, which includes each day between the hours of 12:00 a.m. to 6:00 a.m.

As there were no others present at the meeting, Trustee Baker made the motion to close the public hearing and Trustee LeBaron seconded the motion. All in favor public hearing closed.

Special Meeting**

Mayor Carpenter opened the regular meeting.

The first item on the agenda was the presentation of the following resolution, which Mayor Carpenter read aloud;

At a special meeting of the Village of Schuylerville Board of Trustees held on October 23, 2023, at the Village Municipal Center, 35 Spring Street, Schuylerville, New York 12871, the following Local Law was adopted.

Local Law No. 1 of 2023

Be it enacted by the Village of Schuylerville Board of Trustee, County of Saratoga, State of New York as follows:

Section 1. Title:

Local Law No. 1 of 2023 is entitled “Local Law Amending the Village Code §151-19 with respect to seasonal parking.”

Section 2. Legislative Intent:

It is the intent of this Local Law to define seasonal parking on the streets and roads located within the Village of Schuylerville to ensure safety and efficient maintenance of the streets and roadways during the winter months and to facilitate efficient and cost-effective snow removal operations.

Section 3. Authority:

This Local Law is adopted pursuant to Municipal Home Rule Law Section 10, and Village Code Section 1-7.

Section 4. Body of Local Law No. 1 of 2023:

§151-19 Seasonal Alternate-side parking, is amended as follows:

Notwithstanding any other provision of this chapter, beginning December 1 of each year and continuing through March 31 of the following year, except as may be provided in Schedule XV hereof, on-street parking within the Village of Schuylerville shall be as follows:

- A. Streets running north and south; Broad Street:

- (3) For streets running north and south, **except for** Broad Street, parking shall only be permitted on the east/even side of such streets on Tuesday, Thursday, Saturday and Sunday from 8:00 a.m. to the following day at 8:00 a.m.; and parking shall only be permitted on the west/odd side of such streets on Monday, Wednesday and Friday from 8:00 a.m. to the following day at 8:00 a.m. Parking on such streets at other times is **prohibited**.
- (4) For **Broad Street**, parking is permitted each day from 6:00 a.m. to 11:59 p.m. the same day. Parking is **prohibited** at all other times, which includes each day between the hours 12:00 a.m. to 6:00 a.m.

B. Streets running east and west; Ferry Street:

- 1) For streets running east and west, **except** the section of Ferry Street (State Route 29) that is east of Broad Street, parking shall only be permitted on the south/odd side of such streets on Tuesday, Thursday, Saturday and Sunday from 8:00 a.m. to the following day at 8:00 a.m.; and parking shall only be permitted on the north/even side of such streets on Monday, Wednesday and Friday from 8:00 a.m. to the following day at 8:00 a.m. Parking on such streets at other times is **prohibited**.
- 2) For **Ferry Street** (State Route 29) **located east of Broad Street**, parking is permitted each day from 6:00 a.m. to 11:59 p.m. the same day. Parking is **prohibited** at all other times, which includes each day between the hours of 12:00 a.m. to 6:00 a.m.

Section 5. Severability:

If any provision of this Local law is determined to be unconstitutional or invalid, the validity and enforceability of the remainder shall not be affected.

Section 6. Effective Date:

This Local law shall take effect immediately upon filing with the Secretary of State.

The second item on the agenda was the proposals submitted by Catalfamo and Hoosick Valley Contractors for the installation of a walkway on the western side of the village municipal building that is in front of the offices. This is to alleviate the issue of runoff from Green and Spring Street that is currently waksing into the side of the building.

Catalfamo bid the job at \$8,400 and Hoosick Valley came in at \$8,073.

Trustee Baker made the motion to accept the bid from Hoosick Valley at \$8,073. Trustee Colvin seconded the motion, all in favor, bid approved.

Trustee Colvin made the motion to adjourn the special meeting, Trustee Baker seconded the motion, all in favor, meeting adjourned.
