MEETING MINUTES June 17, 2024

CALL MEETING TO ORDER

Water Commissioner Bryan Drew called the meeting to order and led the pledge of allegiance.

NEW BUSINESS

Review Phase I: Water Capital Project

- ➤ Minutes from April 17, 2024
 - Modification of water main replacement removes Gates Avenue in Victory:

Mayor Dewey questioned the necessity of replacing the Fort Hardy water main as it was upgraded as part of the Capital Project for the Treatment Plant completed 2005/2006. A general discussion was held regarding the length of the main to be replaced and what is planned. Also, discussion of the connection locations near Ft Hardy Park and Ferry Street. It was agreed to not include the Ft Hardy Park section and to add water main replacement entering Victory. This includes keeping the issue at the Pumphouse as a #1 priority. Mayor Carpenter will contact Kathryn Serra on this change in the scope of service and will email Mayor Dewey, Clerk Treasurer Lewsey and Heyman and Water Clerk Breton.

Mayor Carpenter discussed loan rates and was hopeful the rate of 2.75% would remain available. Clerk Treasurer Heyman is working with NYCOM on other rates and will get them out to everyone.

Lead Agency for the project was questioned as has been discussed previously. Mayor Carpenter has accepted Schuylerville as lead agency of the project and that was overall agreed to remain. Carpenter stated they will take the loans out and request reimbursement by the water board.

- ➤ Minutes from April 24, 2024
 - o CT Male to get approval of the Final Engineering Report (to upload to RD Apply) USDA is the administrator of the Congressional Directive Spending Grant.

Mayor Dewey reviewed getting the final plan proposal with the amendment of the scope as discussed as we need to approve this before going forward, not just submitting the engineering report.

Mayor Carpenter liked working with USDA as there is a liaison that works with you on your loan application.

Archaeological phases were discussed and if would be necessary since a Phase 1A and Phase B was completed for the previous Capital Project in this area. Eliminating the Ferry Street water main replacement and the archaeological studies will be a cost savings in this area but allow more water main to be replaced.
